IFC is seeking consultants to assist in assessing the technical feasibility of an FSU-based LNG terminal sited at an anchorage within the port of Freetown, Sierra Leone. The basic concept is an FSU with a spread mooring system in 20-25 meters of water. Initial, high level work is underway now to quickly evaluate marine environmental conditions including wind, wave, current, and marine traffic issues. Building on this work, consultants will be retained to do more detailed feasibility work on all technical aspects related to siting of such a facility, with a focus on achieving a deep understanding of fixed marine infrastructure costs and of operational considerations (including small vessel and ISO container loading, entry/exit of large LNG carriers, and other issues).
