ASSIGNMENT DESCRIPTION

The World Bank is supporting SENELEC, ANER, and AEME to hire a consultant to perform a survey of public buildings in Senegal to assess their suitability for rooftop solar. These buildings will include schools, hospitals, and public administration offices, including ministerial and administrative buildings. The survey will generate the necessary information, including technical and financial parameters, to prepare an EPC contract for the installation of rooftop solar systems in the selected buildings.

The initial aim is to include 15-25 buildings as part of the survey, but this figure will be finalized after consultation with SENELEC and relevant Ministries.

Additional staff may include more junior staff to support data collection/processing, undertaking selected analytical tasks, project implementation, etc. The team must be able to work in French as well as English. Experience in working in the power sector in Africa is desirable.
