"For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing."
2. ZESCO Limited an implementing agency of the Borrower now invites sealed bids from eligible bidders for construction works for Electricity Service Access Project in Northern Province (Kaputa, Mporokoso, Mungwi, Senga Hill Mpulungu and Luwingu Districts) ZESCO/ESAP/W/082/2019.

Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers-Procurement in Investment Projects Financing" July 2016 revised November 2017 and August 2018 ("Procurement Regulations"), and is open to all eligible bidders as defined in the Procurement Regulations.
