ASSIGNMENT DESCRIPTION

The consultant will be expected to conduct the following specific tasks: Task 1: Review the Energy Act and Public Utilities Act, to serve as a robust analytical basis to recommend priority investments for enabling Seychelles energy policy framework that enhances NDC targets which can further be incorporated in the revised NDC.

Task 2: Provide options for regulations based on international best practices. A long-list of regulations is attached in Annex 1. A more refined list will be defined between World Bank and Government of Seychelles at inception stage of the assignment.

Task 3: Providing roadmap for enhancing NDC targets: The Consultant shall and not exclusively, (i) review gaps in the revised Energy Act and NDC targets and then provide a roadmap for enabling renewable energy integration and energy efficiency; (ii) prioritization of activities after consultation with Government, and (iii) develop the financing prospectus.

Task 4: After consulting with the Ministry of Environment, Energy and Climate Change, the World Bank and other relevant Ministries technical staff, the NDC Advisor and NDC Coordinator, as well other energy experts and relevant stakeholder groups, conduct capacity building activities like training or workshops with templates provided for, and not limited to:

Guidelines on how to properly set up a Functioning Regulatory Unit; comprising of (i) requirements of a functional regulator; (ii) draft relevant documents templates i.e. operational manuals, procedures, rules, decisions, guidelines, checklist, best practices etc.; (iii) organizational structure for a Regulatory commission describing the details of staff units/section the Commission should have to discharge both its implementation function and its regulatory function;

Clear procedures on enforcement of these license conditions and how to supervise licensed entity;

Checklist that can be developed for assessing TPA, wheeling agreements, PPA and for monitoring and Supervision etc. to ensure due diligence on the regulator side has been done and how to develop, prepare and draft these; Mechanism to set, review and approve tariff;

o conducting Power Systems Studies and Quality assessment;

o developing an educational and awareness document to be used for educating Stakeholders such policy makers, Members of the Assembly, Board members on the role and function of the Electricity Regulator;
