The Government of the Republic of Zambia has received financing from the World Bank toward the cost of the Electricity Services Access Project (ESAP), and intends to apply part of the proceeds toward payments under the contract for construction works for electricity service access project in Muchinga Province (Mpika and Isoka Districts). For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank's Disbursement Guidelines for Investment Project Financing.
2. ZESCO Limited an implementing agency of the Borrower now invites sealed bids from eligible bidders for construction works for Electricity Service Access Project in Muchinga Province (Mpika and Isoka Districts) ZESCO/ESAP/W/002/2020.
3. Bidding will be conducted through international competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers- Procurement in Investment Projects Financing" July 2016 revised November 2017 and August 2018 ("Procurement Regulations"), and is open to all eligible bidders as defined in the Procurement Regulations.

7. All bids must be accompanied by a Bid Security of at least 2% issued by a bank or 3% if issued by an insurance firm (Bid Bond) of the bid amount on the Bid Submission Form. Bid security, at the bidder's option may be in the form of either a letter of credit or a bank guarantee from a banking institution or a bond issued by an insurance firm as surety.
